

DATA PROTECTION AGREEMENT

In addition, the *Member* hereby gives his/her consent – revocable at any time – to the following information being made available to the *Recommender* to contact the *Member* to offer information regarding new *Loyalty Merchants*, new shopping opportunities, or special offers: *Member ID*, first name and surname, e-mail address and telephone number.

In addition, the *Member* hereby gives his/her consent – revocable at any time – to mWI myWorld India Private Limited to make the following information available to the *Recommender* of the *Member* as well as to his/her *Recommender* (hereinafter referred to as the “indirect *Recommender*”) to keep track of the *Member’s* purchasing activities for accounting purposes: date of *Purchase*, time of *Purchase*, first name and surname, amount of *Purchase*, currency. In lieu of the full first name and surname of the *Member*, only the first name and the first letter of the surname will be shown to the indirect *Recommender*.
